
Operating deficit was \$186,000 Endowment drawdown was 6.6%

TRENDS AND OPPORTUNITIES IDENTIFIED

Trends

- The ESU has realized budget deficits over the past several years.
 - This was partly the result of one-time events (pandemic) and short-term economic fluctuations; and
 - An inherent imbalance in spending vs revenue generation.

Opportunities - medium to long-term horizon


- With the aim to eliminate recurring deficits, the ESU is setting in place a 5-year Institutional Advancement Plan that seeks to address:
 - Increasing revenue, reducing spending (e.g., cutting inefficient programs and costs), developing equitable cost sharing policies, and implementing structural changes to boost organizational efficiency while maintaining our capacity to grow.
- A Task Force, consisting of board members, branch members, and national staff, will be established to provide a comprehensive evaluation of the institutional advancement plan, make recommendations for improvement, and provide implementation support. The task force will also monitor results against performance indicators.

PKF O'Connor Davies, LLP performed an audit of the FY 21/22 Consolidated Financial Statements, and issued an unqualified opinion on the organization-wide Financial Statements – meaning that in the auditor's judgment, the organization's financial statements were fairly and appropriately presented, without any identified exceptions, and in compliance with generally accepted accounting principles (GAAP).

The fiscal year 22/23 audit of the ESU Consolidated Financial Statements is under way and has an estimated completion date of March - April 2024.

ESU USA 100 YEARS

Secondary School Exchange Scholarship (SSE)

The oldest ESU educational program, SSE is a merit-based scholarship that provides tuition, room and board for students to spend a "Gap" Year abroad in the UK or US between high school and college.



Since 1928, the SSE Scholarship has allowed thousands of students to expand their horizons by studying at secondary schools in the US and UK. SSE students gain maturity, independence and global perspectives that benefit them in college and in their future careers. Fourteen students are just begun their studies for the 2023/24 academic year in the US & UK.



Luard Morse Scholarship

This merit-based scholarship provides a \$25,000 award for students from Historically Black Colleges and Universities (HBCUs) to study for a semester at a British University during their junior year. Since 1969, 88 exceptional students have been awarded scholarships to study at 18 Universities including Oxford, Cambridge, & the


London School of Economics.

Middle School Public Debate Program

Founded in 2011 in partnership with Claremont McKenna College, the ESU's Middle School Debate Program teaches students in grades 5-8 fundamentals of critical thinking and language arts skills through public speaking. The program is an adaptation of the parliamentary model of debate.

Students engage in weekly debate activities and all day Saturday tournaments. The ESU Middle School Debate Program had a robust season with a return to debating in-person in 12 tournaments hosted by the New York Debate League, Garden State Debate League and Jersey Shore Debate League. The ESU works closely with a dedicated team of coaches/teachers and volunteer judges to support the students.









International Public Speaking Competition (IPSC)

IPSC brings the best young speakers aged 16 - 20 from all over the world together for a week of competition, training & cultural exchange in London. Each year, over 40,000 students from 50 countries participate.



MEMBERSHIP 2022-2023

- Prior to June 1, 2016, branches were largely unincorporated entities with no legal status.
- LLC structure was implemented throughout the 2016-2017 fiscal year with the National Organization as the "sole member" or "single member".
- Branches could formed as an LLC with one of two Operating Agreements: a Board-Managed Operating Agreement (BMOA) or a Member-Managed Operating Agreement (MMOA).






MEMBERSHIP 2022-2023

- While branches are considered "disregarded entities" in the eyes of the IRS they still have to complete local State compliance.
- Because the branches only have tax-exempt status through the National Organization, the ESU files a single tax return instead of two returns every year.
- Branches determine their own dues levels, additional categories for giving, their own local programming and, in the case of BMOAs, control their own finances.
